

## **Rider for The Manhattan Dolls**

Purchaser to provide the following at no expense to ARTISTS:

1. **TRANSPORTATION:**

Promoter will provide roundtrip airfare and/or rental car for Six (6) Individuals to and from the city of performance from the designated points of origin to be specified. \_\_\_ Init

2. **GROUND TRANSPORTATION: (if there is a flight)**

Promoter to provide transportation for The Manhattan Dolls between the Airport, Hotel And Venue. Promoter to provide at no cost to "The Manhattan Dolls" One (1) SUV/Van for Group And Musicians. Vehicles to be at the disposal of The Manhattan Dolls. \_\_\_ Init

3. **HOUSING: (if an overnight)**

Promoter to provide at no cost to "The Manhattan Dolls", Residence (Hotel Rooms) for The Manhattan Dolls, in the form of Six (6) beds for duration of performance. This can be in the form of Two (2) rooms with Three (3) beds each or similar. \_\_\_ Init

4. **CATERING:**

One (1) Hot Meal (Dinner) For 6 People , Two (2) cases of water to be provided Per Day for duration of performances. Sandwiches (or similar), Sodas and Juices to be provided for Lunch two hours before performance. \_\_\_ Init

5. **DRESSING ROOMS:**

Promoter to provide One Dressing Room For Three (3) People, Clean And Well Lit With Mirrors For "The Manhattan Dolls", One Dressing Room For Three (3) People, Clean And Well Lit With Mirrors For The Band. Both Rooms To Have Bottled Water, an Iron and Ironing Board In Each. \_\_\_ Init

6. **SOUND REQUIREMENTS:**

Purchaser shall obtain and provide at his sole expense a first class sound system capable of reproducing undistorted, evenly distributed sound.

- a. Artist must be provided with Three (3) first class wireless mics,
- b. Two (2) on stage monitors for vocals and speakers directed to the house
- c. Purchaser to provide One (1) keyboard (Yamaha or similar) connected to sound system with amplification through monitors and house speakers,
- d. One (1) drum kit properly amplified and
- e. One (1) microphone on a stand for brass instrument amplification through house speakers.
- f. Purchaser to provide experienced, competent sound technicians for sound check, rehearsal (if any) and performance.
- g. Purchaser agrees to have all sound equipment set up, and operable prior to Artist's sound check.

7. **TICKETS:**

Promoter shall be deemed fully responsible for any and all tickets (legal and counterfeit) and under no circumstances shall the act absorb any loss as a result of such tickets.

No tickets are to be sold for seats any place on the stage area, promoter shall provide adequate seating for guests of "The Manhattan Dolls". \_\_\_Ini

8. **ADVERTISING:**

- a. Artists shall receive 100% billing in any and all publicity releases and paid advertisements, including but not limited to programs, flyers, signs, lobby boards and marquees unless otherwise specified. The following is the only acceptable way Artists shall be billed:

- b. Purchaser agrees to use only publicity materials provided by Artist or representative and further agrees that all advertising and publicity is subject to approval prior to release.
- c. Purchaser will not permit Artist's name to be used or associated directly or indirectly within product or service without the Artist's written consent.
- d. Purchaser will not permit the recording or broadcast, oral and/or visual, of any performance without the express prior consent of the Artist.

9. **INDEMNIFICATION:**

Purchaser agrees to hold harmless Producer/Artist and its employees, subcontractors, managers and or agents from and against any claims, costs (including attorney's fees and court cost), expenses, damage, liabilities, losses or judgments arising out of, or in connection with, any claim, demand or action made by any third party, if such are sustained as direct or indirect consequence of this engagement.

10. **TAXES:**

Purchaser shall pay and hold Producer/Artist harmless of and from any and all taxes, fees, dues and similar financial events relating to the engagement hereunder and the sums payable to Producer/Artist shall be free of any deductions.

11. **SETTLEMENT:**

All balances shall be paid to Heather Dispensa, Sarah Drake or authorized representative **IN CASH or CHECK made out to "The Manhattan Dolls" No Less Than ONE (1) HOUR** before showtime.

THE ABOVE AND ALL ITS ATTACHMENTS CONSTITUTES THE SOLE, COMPLETE AND BINDING AGREEMENT BETWEEN THE PARTIES HERETO. THIS ENTIRE CONTRACT HAS BEEN READ AND ENTIRELY UNDERSTOOD BY THE UNDERSIGNED, AS HAS BEEN ALL ITS ATTACHED RIDERS AND TERMS.
